Personal data are collected by meeting organisers through the template "overview of participation in meetings". The personal data collected through these templates are then consolidated in Excel sheets according to the format provided by the Secretariat General, and sent to the member in the Business Continuity Team in charge of submitting the data to the Secretariat General.
